# KAUPAPA

As a by-Māori, of-Māori, with-Māori and for-Māori\* body, Ngā Toki Whakarururanga will set the bar for trade policy and agreements that are consistent with Te Tiriti o Waitangi. Ngā Toki Whakarururanga will bring a new leadership model to every stage of the policy development process that reflects its kaupapa/mission statement:

*“Mana whakahaere in the global domain is informed by Rangatiratanga and Kāwanatanga working together in a mana-enhancing relationship of equals, consistent with Te Tiriti o Waitangi and He Whakaputanga o Te Rangatiratanga o Nu Tireni.”*

\* When the term Māori is used in the document it includes Moriori, hapū and iwi, pan-tribal and urban Māori groups, landowners and other entities that exercise rangatiranga and represent those with whakapapa to tāngata whenua of these islands.

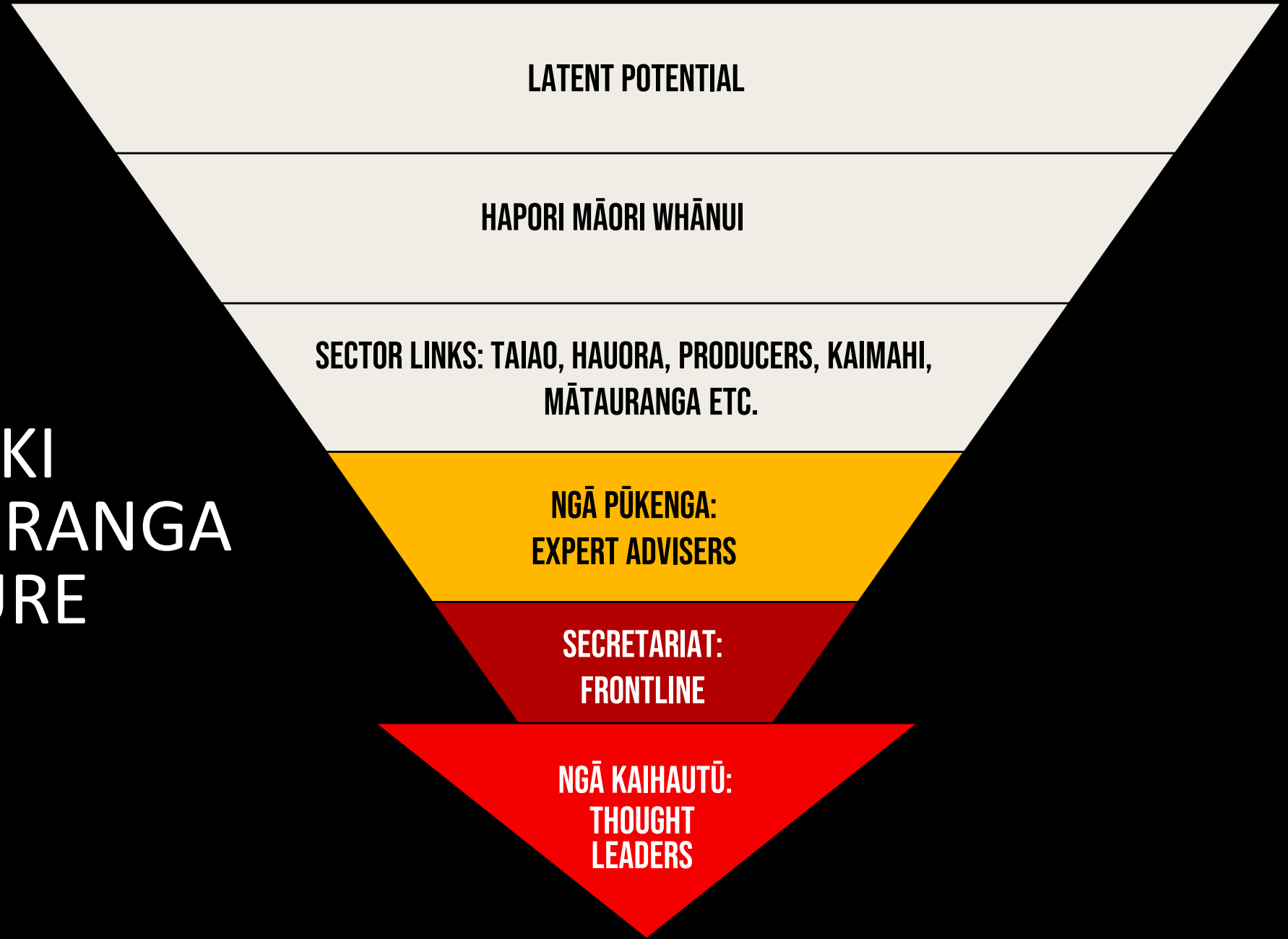

# NGĀ TOKI WHAKARURURANGA STRUCTURE



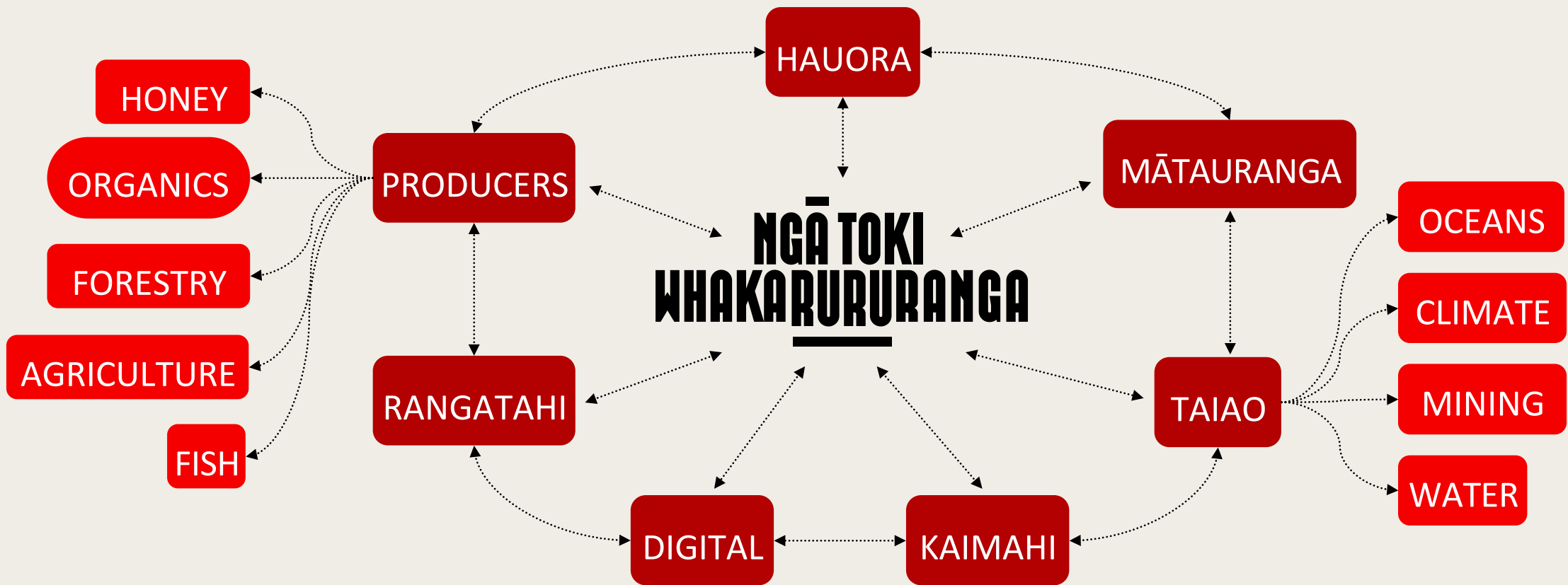


# CRITERIA FOR NGĀ KAIHAUTŪ

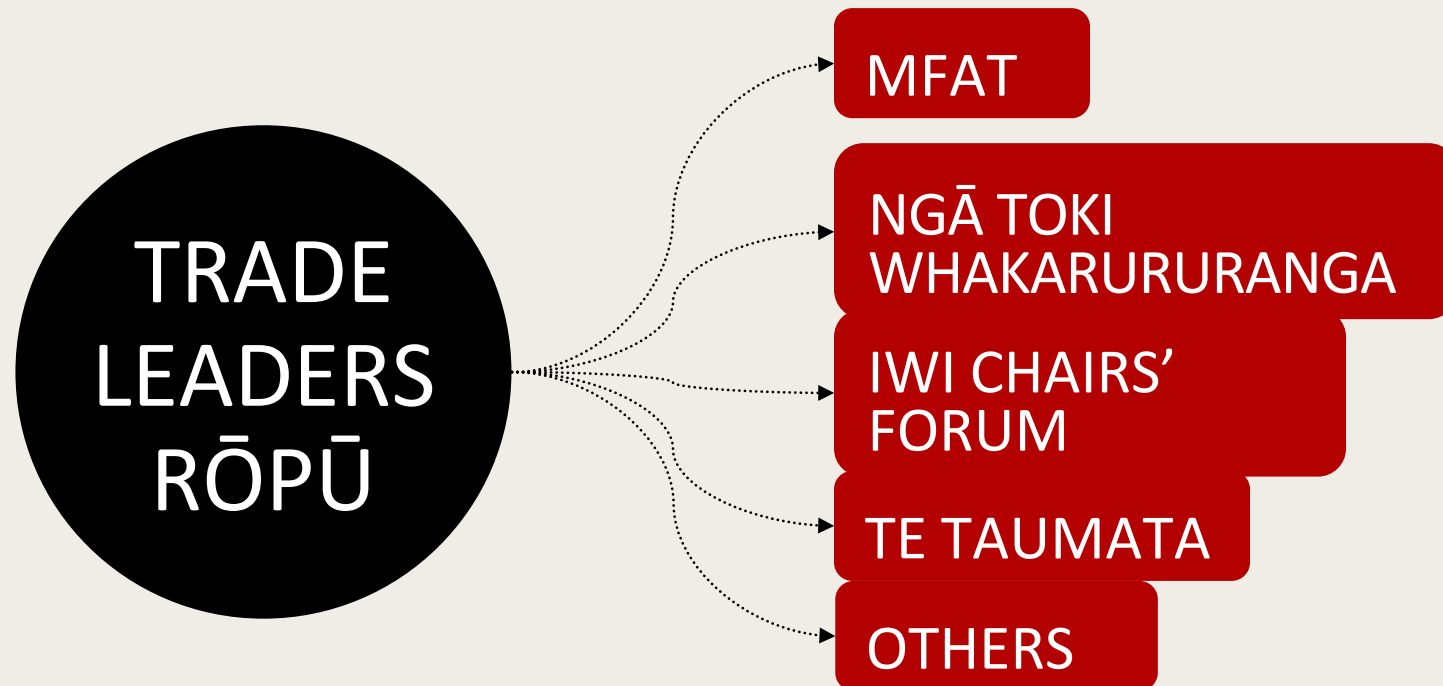
- Commitment to rangatiratanga, Te Tiriti o Waitangi me He Whakaputanga
- Can think outside the box and be disruptive and decolonising. Has a vision for transformation and know how to realise it
- Can incorporate a historical lens that recognises colonisation and racism was once led by states, now also by corporations
- Think of trade beyond capitalist commercial entities to decolonising and re-indigenising as a non-capitalist social enterprise
- Committed to protecting Te Ao Māori from negative impacts of trade rules
- Availability to the kaupapa and prioritising it as part of their role. Commitment to stepping back and finding a replacement when they can no longer do it
- Committed to a team approach and building many bridges to others in their sector and beyond

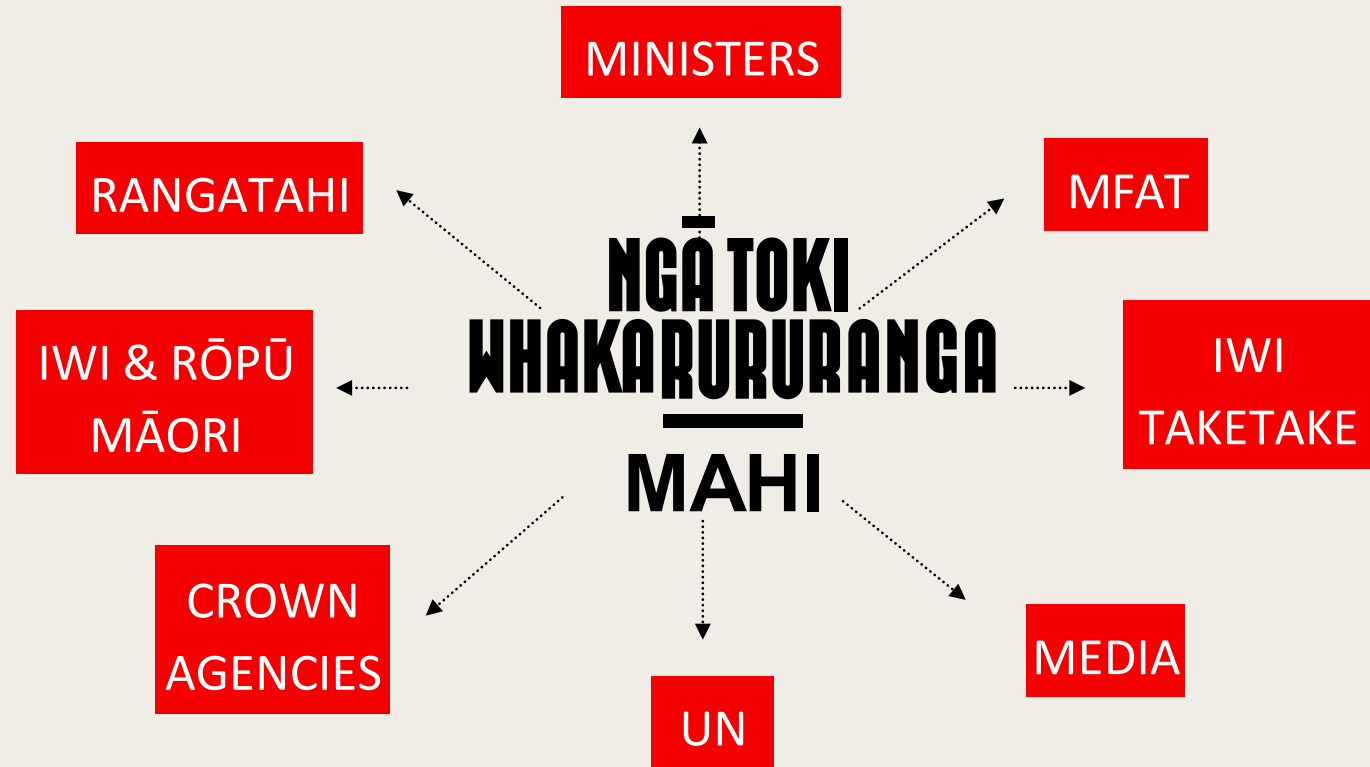
